Council would like to draw attention to the streetscape and the situation and location of nearby heritage buildings including any grade 2 listed buildings. How far will the hedge line be taken back to? Any encroachment on to Parish land, The Green, will require permission (Title no ON129117 registered to the Parish Council). See attached. The parking requirements including the visibility splays require a detailed design to incorporate issues Highways have highlighted. The position of the air pump must take into consideration the distance from the tree, the hedge line, and the house itself to prevent any foliage/foreign body impacting on its function. The positioning of the air pump should not impact on the environment or neighbours. This site is on a prominent position on the Village Green any change to the street scene needs to be carefully considered.
