REPORTS

27/22 Report from County Councillor.

Council administration. The interim CEO at county was appointed: Stephen Chandler was appointed last month until a permanent CEO is recruited. He was OCC's Director of Adult Social Care and chair of the national Assoc of Care Providers and knows OCC well. We still do not know what impact or costs will affect OCC from the termination of the outgoing CEO. Transport issues. LTCP consultation is now closing. Early headlines emerging include residents' concerns that rural transport and connectivity is not strong enough theme in the thinking. Dealing with inequalities and the disabled are also concerns coming through, but I think aspects of rural transport impact us most keenly.

EEH Corridor Study on A34 and A420 will hold its first meeting on 16 March 2022. I will attend and report back to you at your next meeting. 20mph speed limit makes its slow progress, now with a trial in Wallingford

Locally. County Highways works teams have been upgrading the B4507 as I promised they would 2 years ago! This is the programme of re-surfacing decided and funded in my time in post and I am pleased to see such thorough work carried out, with proper reconstruction of many of the edges (haunches) and repairing whole stretches of road in a way that is intended to last. The programme extends for the whole of B4507, and works have been/are being carried out from Wantage to Idstone, where I hope residents will be able to move with the number of works notified to me in past week.

28/22 Report from District Councillor.

Planning update. Bluestone Townsend Road, Shrivenham 26 dwellings. This application has been delayed due to additional information requested from the developer which to date has not been forthcoming. It is anticipated that a decision will be made by the end of the month. Gladman. A revised submission for 90 dwellings has been submitted along with landscape and other reports. As a result, the decision date will be extended. It is interesting to note that the CCG has recently responded a second time to this application. Broadleaze, Longcot Road appeal lost.

I have been appointed on to the Faringdon Area Traffic Advisory Committee.

At the full Council meeting on 16 February 2022 the budget was approved.

The average Council Tax for a Band D property will increase by 4.71%.

Electric Vehicle charging points are being installed at Southampton Street carpark, Faringdon.

Council requests more detailed plans of the heights and footprint in relation to the buildings surrounding the application so the others are not swamped by the large extension, and the look of the extension is not out of keeping with the other listed buildings that are the neighbourhood. No pictures or details of the proposed outbuilding have been supplied; the picture supplied states that it is similar, not actual. This will need to be included within the drainage plan.
