We have residents who pick litter all the time along Fernham road and Kings Lane, and we are so grateful as they take great pride and pick up so much litter that has been thrown out of cars.

We were rather shocked this year to be sent a court order for a speeding fine in London for the Longcot owned lawn mower. We had to prove to the court that it was actually a lawn mower and would not make it to London, let alone be able to speed!

We have applied to get the OCC 20 mph sign put up outside the school and wait the outcome.

The track at the dash is becoming wider and more damaged, so council are looking to gate the entrance and will be working on that this year.

We continue to work with both the District and County Councils for the upkeep of the drainage system as this is vital in our village due to the flooding issues. It is noted that we have a lot more standing water on Fernham Road, these are the things that we have to continue to investigate.

Councillors were reminded that, under the Council's Code of Conduct, Councillors were required to set out their interests under the appropriate headings and to make amendments when appropriate. 74/23 Council Procedures, Policies and Information and Guidance Documents.

75/23 General Power of Competence.

Council meets the criteria for eligibility, the Clerk has passed the Certificate in Local Council Administration and all members were declared elected. Council RESOLVED that from 4 May 2023 until the next relevant Annual Meeting of the Council that having met the conditions of eligibility as defined in the Localism Act 2011 and SI 965 the Parish Councils (General Power of Competence) (Prescribed Conditions) Order 2012 to adopt the General Power of Competence.

(Clerk's Note: The General Power of Competence (GPC) was introduced by the Localism Act 2011 and took effect in February 2012. In simple terms, it gives Councils the power to do anything an individual can do provided it is not prohibited by other legislation. It applies to all principal Councils (District, County and Unitary Councils etc.). It also applies to eligible Parish and Town Councils. It replaces the wellbeing powers in England that were provided under the Local Government Act 2000. An eligible council is one which has resolved to adopt the GPC, with at least two thirds of its members being declared elected and the Clerk must hold an appropriate qualification ie a Certificate in Local Council Administration, Certificate of Higher Education in Local Policy, Certificate of Higher Education in Local Council Administration or the first level of the Foundation Degree in Community Engagement and Governance (University of Gloucestershire).
