157/23 Minutes of the Parish Council held on Thursday 28 September 2023.

158/23 Matters arising from the minutes.

Hedges have been cut back and quotes obtained for all work to be undertaken at The Dash. **159/23 Public Participation.**

Mr Stoves, Holly Cottage has offered to pay 50% towards repairs to the surface of the track. Council thanked Mr Stoves and that confirmation of his offer would need to be in writing once a quote had been agreed and prior to starting the work. Mr Stoves confirmed that he does not object to the fencing Council is considering installing but that all utilities must be accounted for. Holly Cottage has a pump going across The Dash which Council was unaware of and no permission had been given, this would need to be addressed. A sign would be erected on the fence to say 'Do not block access needed at all times'. Mr Stoves asked if a section of fence could be dismantled for access if required. This would be considered.

CC Constance reported that she had received complaints of drivers parking, leaving engines on, and blocking driveways and gates around the school. The Chair would write to the school.

162/23 Chairs report.

- i. The 20mph signs have been installed at Kings Lane and Mallins Lane.
- ii. Flooding at the bridge. Council has requested a new gauge and has been in contact with OCC and VWHDC and has been informed that the gullies would be cleared soon. OCC has been asked to contact Network Rail to contribute to costs as the bridge is underwater again and this must have an impact on the structure of the bridge.
- iii. Council has received a request from residents of Kings Farm Close for access to the mower. Council checked the documents relating to the development regarding mowing the open spaces but were told that if this was to happen then the open spaces would become the responsibility of Council. This was never agreed. A management company was set up to carry out this maintenance.
- iv. Council reported to OCC and VWHDC drains that required clearing as some areas were blocked and overflowing mostly outside the Methodist Church area.
- **v.** The drainage system outside Kings Farm Close has been unblocked. There is a dispute over ownership of the drainage grate, land registry shows that it belongs to the new development.
